

Main progress in 24 months

Police



10 % HNP force. 15,400 police officers.



► 56 % policewomen

(from 1,028 to 1,601 in September 2019), representing 10.4 % of the total police force.



95 % of the operations conducted without support from MINUJUSTH, which limited its assistance to 127 law enforcement/crowd control interventions and 29 anti-gang operations.



1 / infrastructures built with UN support.

171 HPN senior officers

benefited from mentoring and transfer of competencies in support of the SDP³ 2017-2021 (34,5 % implementation rate).



Fight against sexual and sexist violence crimes A specialized unit created within the DCPJ⁴

Rule of law



300% court files processed on the same day of their reception by the Port-au-Prince Public Prosecutor's Office. (787 between January-August 2019. 257 in 2018).



2,946 files of prisoners in pre-trial detention addressed by the BAL⁵, (target of 2,300 already exceeded).

4 prisons certified to international standards.
